## Resolution No. 2011-04

## A RESOLUTION OF THE COMMISSIONERS OF RIDGELY INCREASING THE CHARGES TO USERS OF THE TOWN WATER AND WASTEWATER SYSTEMS

WHEREAS, the Commissioners of Ridgely are authorized by Section 185-16.C (Sewer charges established), to establish, by resolution, charges to users of the Town wastewater system,

And WHEREAS, the Commissioners of Ridgely are authorized by Section 185-15.C (Water charges established), to establish, by resolution, charges to users of the Town water system,

## BE IT RESOLVED BY THE COMMISSIONERS OF RIDGELY:

SECTION 1: The Maryland Department of the Environment Maryland Water Quality Financing Administration has provided zero interest financing for major improvements to the Wastewater Treatment Plant with the stipulation that Ridgely water and wastewater rates will be increased by 1/3<sup>rd</sup> (11% each of three consecutive years) starting with October 1, 2009.

C. Commercial - Industrial

SECTION 3: Users of Town water/wastewater systems who reside outside the corporate limits of the Town are required to pay the full cost of delivering water and sewer service. The quarterly fee shall include administrative and other costs shared with other Town government expenses. This fee for services shall be equal to 50% of the current minimal usage fee.
