## Request an absentee ballot

Anyone registered to vote in the Town of Ridgely Elections can use this form to request an absentee ballot for the election.

## How do I return this form?

Return your completed signed form by mail or in person:

## How will I receive my ballot?

The primary way to receive your ballot is by certified mail. We can mail your ballot to any address you want. You will also receive a return envelope with prepaid postage.

You can also pick up your ballot in person at the Ridgely Town Hall. If you want someone to pick up your ballot for you, you must provide a Designation of Agent form, available at the town office and online at [www.ridgelymd.org](http://www.ridgelymd.org).

## Deadlines to return this form

Mailed or hand-delivered requests must be in the Town Hall office, 2 Central Ave. Ridgely, MD 21660, by **12:00 pm on Monday April 13, 2026**. Postmarks do not count.
