# COMMISSIONERS OF RIDGELY NOVEMBER 4, 2019 TOWN MEETING



The Commissioners of Ridgely met on the above date in the town hall at 7:00 pm for the November 2019 Town Meeting. President Casey opened the meeting with the Pledge of Allegiance.

Commissioner Hurley made a motion to approve the October 7, 2019 Town Meeting minutes, 2<sup>nd</sup> Commissioner Buckle, approved.

## STAFF REPORTS CLERK-TREASURER

Commissioner Hurley made a motion to approve paying the bills, 2<sup>nd</sup> Commissioner Buckle, all in favor, approved.

Total General Funds Reconciled \$267,202.53

Total Sewer Funds Reconciled \$140.595.53

Total Water Funds Reconciled \$43,560.20

Edward Bombaro pled guilty to fraud. He had posed as an architect and did work for our train station. He had to pay restitution to the town in the amount of \$9,000. We will be using a portion of that money to decorate the Railroad Park for Christmas. The rest will be used for other park items.

Caroline Hospice is doing the festival of trees and needs decorated trees donated to the festival so that they can be auctioned. This is a big fund raiser for hospice. Commissioner Hurley made a motion to have a \$500 budget for a tree to donate, 2<sup>nd</sup> Commissioner Buckle, all in favor, approved.

David Crist presented his report to the Commissioners.

Chief Gary Manos presented his report to the Commissioners.

### **ZONING ADMINISTRATOR**

Melissa Leonard said that Hal Davis has been approved to join planning and zoning. He will need a letter with the request to join and he can be appointed in January.

#### **FINANCIAL ASSISTANT**

Jerry Sutton said that the audit went well and we are hoping to have a draft in a few days from the auditors.

### STATE'S ATTORNEY

Joe Riley reviewed the October 2019 convictions for Ridgely.

### HISTORICAL SOCIETY

Cathy Schwab told the Commissioners that the wagon that had been at the train station is being repaired by CCTC. They discussed plans for the new wagon and grant opportunities to build a platform at the end of the trail.

### **OLD BUSINESS**

Brenda Wall from the Ridgely Car Show thanked the Town for 9 years of help and support. 14 organizations will be receiving money from the car show, including the Ridgely Volunteer Fire Department. The organization will continue to do charity work, but not as a car show.

## **NEW BUSINESS**

David Bowen and Glenn Kelley from Cambio Broadband came to discuss their desire to put wifi equipment on the town's water tower. A discussion followed. They were instructed to get more information from the water tower maintenance company and the Director of Public Works.

### **PUBLIC COMMENT**

Brenda Walls is hoping to do something in the Railroad Park before the Christmas Parade. She discussed possible ideas.
