# COMMISSIONERS OF RIDGELY DECEMBER 2, 2019 TOWN MEETING



Summary of the December 2, 2019 closed session:

## **DIRECTOR OF PUBLIC WORKS**

David Crist presented his report to the Commissioners. President Casey asked about enforcing no parking in front of the train station. Chief Manos and Sgt. Geesey informed him that in order to legally enforce the no parking, signs must be installed. David Crist indicated that State Highway would have to install the signs, not the town.

## CHIEF OF POLICE

Chief Gary Manos presented his report to the Commissioners.

## **ZONING ADMINISTRATOR**

Melissa Leonard invited the Commissioners to attend the December 18<sup>th</sup> planning and zoning meeting where they will be discussing the zoning ordinance.

#### FINANCIAL ASSISTANT

Gerald Sutton told the Commissioners that the audit is in the final stages and we hope that TGM Group will be here in January to present the report. He discussed the local income tax and piggy back taxes and why we receive the larger payments at the end of the fiscal year.

## STATE'S ATTORNEY

Chief Manos received an email message from State's Attorney Joe Riley indicating that he would not be at the meeting tonight.

#### HISTORICAL SOCIETY

Cathy Schwab commented how beautiful the town looks. Created in Caroline was held at the train station and went well. RHS will continue with the 9<sup>th</sup> year of the Christmas Home and Business Decorating Contest. December 18<sup>th</sup> will be the day they pick the winners. There will be a free raffle for 2 bikes after the Christmas parade on December 7<sup>th</sup>. It will be at the train station before and after the parade.

## **NEW BUSINESS**

Rob Crimmins of the United States Parachute Association talked to the Commissioners about a drop zone at the Ridgely Airpark. He presented a packet of benefits to the town for the Commissioners to consider.

John Gooden from the Ridgely Airpark introduced himself and discussed his plans for the airport. Chief Manos asked if there would be camping and partying at the airport the evening before a jump. A discussion followed. He also discussed his desire to try to get his taxes lowered and to be able to have town water and sewer at the airpark. A discussion followed. Debbie Bowden from Caroline County Economic Development discussed that perhaps there is a way for economic development can help and explore the options that he would have.

## **PUBLIC COMMENT**

Joe Anderson reported on the Ridgely Car Show Foundation that they gave \$76,000 to 13 charities.

Gerald Sutton told everyone that the Ridgley Lions hung the lights across the streets.

Melissa Leonard spoke on behalf of the Caroline Cougars Cheer requesting a donation. President Casey made a motion to give \$500, 2<sup>nd</sup> Commissioner Hurley, approved.
