Chief Eckrich introduced the new police officer PFC Dalton De Crispino. He comes to us from Prince George's County. Stephanie Berkey swore in PFC De Crispino.

## **ZONING ADMINISTRATOR**

Melissa Leonard had nothing to report. Commissioner Hurley brought up the house on Maryland Avenue that is being rebuilt. The builders can get around the town code by leaving up a small piece of the original house and rebuilding everything else. This allows them to avoid impact fees and having to add a sprinkler system to the house. He would like to see future zoning laws changed so that this practice cannot continue. Melissa will investigate this at future zoning meetings.
