The meeting was adjourned at 7:12 pm.

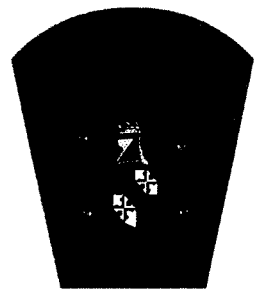

Attended the Administrators Meeting at the Board of Education and spoke to administrator, principals and staff about school safety. We always have an officer on duty during school hours and school events. Our officers are visiting the school throughout the school day.

The Department and the Caroline County Drug Task Force hosted a two (2) day training session at the new Ridgely Volunteer Fire Department. Each day there were officers in attendance from the mid shore and Anne Arundel County. We would like to thank the RVFD for their assistance with the training.

The Police Department has investigated two deaths in the past week. One victim was under a doctor's care and neither death is considered suspicious at this time.

The North Caroline Little League Opening Day Parade is scheduled for April 14<sup>th</sup>. During the parade Central Avenue will be closed. We have already secured the State Highway Special Events Permit.
