Commissioner Hurley made a motion to approve the minutes from the October 7, 2013 meeting, 2nd Commissioner Buckle, approved.

STAFF REPORTS CLERK-TREASURER

Commissioner Buckle made a motion to approve paying the bills, 2nd Commissioner Hurley, approved.

Total General Funds Reconciled \$391,358.23, Total Sewer Funds Reconciled \$120,048.11, Total Water Funds Reconciled \$122,181.48.

DIRECTOR OF PUBLIC WORKS

Director of Public Works David Crist presented his report to the Commissioners. Purchase Order #2348 was submitted to the Commissioners regarding the push broom, gutter brush and sweeper attachment for the bobcat from Burke Equipment. Commissioner Hurley made a motion to approve purchase order #2348, 2nd Commissioner Buckle, approved.

There was a discussion about the bulk pick-up policy. The Commissioners would like us to look into what the neighboring towns do for bulk pick-up.

The wires were cut to the lights at the pavilion at Martin Sutton Park, an electrician is scheduled to fix it.

Leaf pick up is ongoing. Public Works is going out once a week with the leaf vac. Millings in the alleys have been finished. Bramble provides the town with the millings for free.


CHIEF OF POLICE





Chief Manos and Sergeant Creason attended the Incident Response to Terrorist Bombing School. The course of instruction was offer by FEMA and held at New Mexico Tech, in Socurro, New Mexico. The training was very informative and intense. Students were able to view and handle the explosives. This was not a Bomb Technician School. This school instructed students on the proper response to Bomb Threats ie.. Pipe Bombs, Improvised Explosive Devices ect. and the safest way to evacuate the scene of a bombing. Instruction was also gained on structure safety after the blast and proper search and rescue techniques. There was no cost for this training.

During the month Chief Manos responded to a residence on Sunrise Avenue. A family member who had been cleaning the residence had discovered a box of blasting caps. Chief Manos recognized the box to contain 15 blasting caps from the training that he just recently received. The area was cleared and the State of Maryland Fire Marshal's Office was notified. The blasting caps were disposed of by the State Fire Marshal's Office Marshal.

We have selected two candidates for the part-time police officer positions. Both candidates are recently retired police officers. The candidates must complete a polygraph examination, psychological examination, drug test, financial examination, finger print examination, criminal records check, background investigation, 18 hours of inservice training hours and weapons qualification. We are hoping to have the officers available by December 1st.

We did not have any issues with the enormous amount of people that visited the town for Trick or Treat. We had 3 officers on patrol that evening.
